 Branch Eastward to a white oak tree on North side
 of the Branch thence Northward to a white oak tree
 on the meeting house road thence Southward to a
 Black Oak tree the North East corner of the
 aforesaid lot of land thence with said Road to the
 beginning corner containing one acre more or
 less in consideration of the sum of ten dollars
 to me in hand paid Sarah Farmer together with
 all and singular the rights members hereditaments
 and appurtenances to the premises belonging or in any
 wise incident or appertaining to have and to hold all
 and singular the premises before mentioned unto the
 said B. E. Chastain his heirs and assigns forever and I
 do hereby bind myself my heirs executors administra-
