

Twelve Hundred Dollars to me in hand paid at and before the sealing of these presents, by Mrs Sophia W Jenkins of Greenville County in the State aforesaid, (the receipt whereof is hereby acknowledged) have granted bargain sold and released and by these presents do grant bargain sell and release unto the said Mrs Sophia W Jenkins all that certain piece parcel or tract of land situate lying and being in the State and County aforesaid about one 1/2 miles from the City of Greenville on both sides of the Anderson Road Beginning on a stake in the centre of the track of the Greenville & Col R. R. and on the South side of a small Bridge crossing said R. R. and runs thence North 19 1/2 West six chs fifty four links (cross the Anderson Road) to a stake on the side of 0th Road thence along the edge of said R. R. N 5 1/2 E one chain & fifty links to a stake on the side of said Road thence with Mrs B^s land N 5 1/2 W eleven chs sixty four links crossing a small branch to a stake 3x thence with Mrs B^s land South 35 W thirteen chs seven links crossing the North fork of Prushy Creek to a large Rock & o.m. thence with Mrs Taffs line S 20 E five chs eight links (crossing said Prushy Creek twice) to a stake & o.m Mrs Taffs corner thence crossing the Anderson Road S 35 1/2 E five chs twenty five links to a stake near the Bank of the said creek thence with the centre of said Greenville & Col R. R. Road three chains fifty links to one bend four chs twenty three links to another point & six chs thirty five links to the beginning corner in said R. R. containing by survey and plat made by H. P.
