may in anywise concern, I, S. J. Douthitt Judge of Probate for the County of Greenville in the said State send greeting, whereas Micajah B. Harrison, J. M. Harrison, J. Henry Harrison, Ida L. Mauldin and Fannie Harrison on or about the 8<sup>th</sup> January 1875 did exhibit their Petition in the Court of Probate at Greenville Court House in the County of Greenville and State aforesaid against Wade B. Harrison Thomas G. Harrison and Anna M. Harrison. And the cause being at issue before the Honorable Court aforesaid, came on to be heard on the 20<sup>d</sup> day of April 1875 when the said Court after full hearing thereof, and mature deliberation in the premises, did order, adjudge and decree that the tract of land belonging to the Estate of Nancy Harrison deceased, hereinafter mentioned and described should be vested in Mrs. Ida L. Mauldin at the sum of Two thousand two hundred and twenty one dollars, the appraised value of the same. Now know all men that I, the said S. J. Douthitt Judge of Probate of Greenville County, in consideration of the premises and also in consideration of the sum of Two thousand two hundred and twenty one Dollars paid me by the said Mrs. Ida L. Mauldin the receipt whereof is hereby acknowledged have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Mrs. Ida L.
