me paid by Nancy A Heill of the town of Lenoir in the
County of Greeneville and State of North Carolina have
granted bargained sold and released and by these presents
do grant bargain sell and release unto the said Nancy A
Heill all my interest and claim in a certain piece or parcel
of land situated lying and being in the town of Lenoir in the County
of Greeneville and State of North Carolina containing four acres
more or less and bounded by lands of Dr. H. V. Westover and
the Mostella and Chick Springs roads known in the survey
made by the P. Johnson as lot No 47 and was sold as the
property of J. K. Jenkins at Sheriff's sale in December 1876 and
was bought by Nancy A Heill and myself jointly lot more
particularly described in a plat survey and made by James B.
Dickson Sept. dinner bearing date March 17th 1877. Together
with all and singular the rights members hereditaments and
appurtenances to the said premises belonging or in any
wise incident or appertaining. To have and to hold all
and singular the premises before mentioned unto the
said Nancy A Heill her heirs and assigns forever and
I do hereby bind myself, my heirs executors and admin-
istrators to warrant and forever defend all and singular
