Instruments that I Isaac Bellew  
of the State and County

aforsaid for in consideration of the sum of seventy five  
Dollars to me in hand paid by Nancy Harrison of  
the State and County aforsaid the receipt whereof is hereby  
acknowledged and for and in consideration of the same have  
bargained sold and released unto the said Nancy Harrison  
a certain tract or parcel of land situated in the State  
and County aforsaid lying on the head waters of South  
Pacolet River Beginning on a Sourwood tree a condi-  
tional corner on the old line thence with the said line  
to the double Chestnut tree thence Northeastward to a  
Dogwood tree thence Northwest to a Spanish oak tree  
thence westward a few paces to a conditional stone  
corner thence down the Branch a conditional  
line Southward to a Pine near the Church thence  
Westward to a Black Gum on the Big Branch  
thence with said Branch to a stone corner at the fork  
of the Branch thence up the Branch to a Maple  
at the head of the Branch thence to the beginning  
corner containing Seventy five acres more or less  
together with all and singular the rights members  
hereditaments and appurtenances belonging to the  
same or in anywise incident or appertaining  
to the same I the said Isaac Bellew doth for  
myself my heirs executors administrators and  
assigns forever warrant and defend the same  
for myself my heirs executors administrators and  
assigns unto the said Nancy Harrison her heirs  
and assigns forever against myself my heirs and  
every other person or persons so claiming or to claim  
As witness whereof I have hereunto set my hand and

37 on the Jones Gap road thence N 76 E 40 50 to a stone 37  
thence N 57 W 27 00 to a stone 37 thence S 85 W 15 00 to a  
P. O. on a road thence with said road S 20 1/2 W 7 00 to a  
beud in said road thence S 10 90 to another beud thence  
S 2 1/4 W 4 20 to a P. O. 37 on Jones Gap road thence  
with said road to the beginning corner and contain-  
ing ninety one acres more or less Also all that piece  
or parcel of land situate lying and being in the State and  
County aforsaid on the Jones Gap road adjoining  
the above described tract of land beginning at a P. O. 37  
on said road thence S 28 1/2 W 5 60 to a stone 37 thence  
S 86 E 5 25 to a stone 37 thence S 15 E 5 75 to a stone 37  
thence N 70 1/2 E 4 50 to a stone on said road thence N 70  
W 15 00 with said road to the beginning corner and  
containing three and a half acres more or less
