S. J. Douthick Master	to	Deed	State of South Carolina County of Greenville
Anna M. Harrison			To all to whom these presents shall come or be made

Known or whom the same may in any wise concern,
S. J. Douthick Master of the County of Greenville in the
State aforesaid, send greeting, whereas a Petition was filed
in the Probate Court for said State and County on the
5th day of October 1875 by Micajah B. Harrison and
others against Thomas G. Harrison and Anna M.
Harrison to partition the real estate of Nancy Harri-
son deceased, and whereas the said real estate was
partially partitioned under said proceedings and whereas
it has since been decided by the Supreme Court that
the Probate Court was without jurisdiction in such
cases, and whereas it became necessary to institute
proceedings in the Court of Common Pleas for the
State and County aforesaid to confirm the
said partition, and whereas a complaint was filed
in said Court of Common Pleas on the 20th day
of October 1879 by Micajah B. Harrison against
Thomas G. Harrison and others and upon the hearing
of said cause the said Court amongst other things

did order, adjudge and decree, that the said partition be
confirmed, and that the Master should execute to the present
owners of the respective tracts of land confirmatory titles
thereto, and whereas Anna M. Harrison is still the present
owner of the tract of land assigned to her in said partition
in the Probate Court. Now therefore know all men by these
presents, that S. J. Douthick Master in and for the County and
State aforesaid in consideration of the premises, and of the
sum of Three Dollars paid me by Anna M. Harrison, the
receipt whereof is hereby acknowledged, have granted, bargained
and sold and released and by these presents do grant
bargain and release unto the said Anna M. Harrison
and her heirs and assigns, all that tract of land situate
lying and being in the County of Greenville and State afove-
said, adjoining lands of Robert G. Shumate, Mrs. M. Hopkins
and others, and containing three hundred and forty four
acres more or less being more particularly described in
the deed by the Probate Judge to the said Anna M. Harrison
together with all and singular the rights, members, heredita-
ments and appurtenances whatsoever to the said tract
of land, belonging or in any wise appertaining, also
the reversions and remainders, rents, issues and profits
thereof, And also all the estate, right, title, interest, dower,
possession, property, benefit, claim and demand whatsoever
both at Law and in Equity of the said Nancy Harrison
deceased, and of all the parties to the said suit, and
of all other persons rightfully claiming or to claim the
same or any part thereof, by, from or under them, or
either of them. To have and to hold the said tract of land
with its hereditaments, privileges and appurtenances unto
the said Anna M. Harrison, her heirs and assigns
forever.
