 situate in the State and County aforesaid on
 the South side of Harper's Creek and adjoin-
 ing lands of Francis Moore and others containing
 five and one half acres more or less beginning
 at a stone or on bank the aforesaid land
 thence S 1/4 W 65 ch to a Pine or on thence S 87 1/2 W
 9.25 ch to a stone or on thence S 1/2 E 7.25 ch
 to a stone or on bank of the aforesaid creek thence
