the said party of the first part, for and in considerat-
ion of the sum of Two hundred Dollars, lawful
money of the United States, to her in hand paid by
the said parties of the second part, at or before the
sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, have released, rela-
ased and quit-claimed, and by these presents do release
release and quit-claim unto the said parties of the
second part and to their heirs and assigns forever all
that certain piece or parcel of land lying and being
situated in the County of Greenville and State of South
Carolina near the Village of Lawrenceville and bound
and by lands of James Parrott, M. L. Davis, Elford
Campbell and Dr. W. A. Mosley, containing two hun-
dred acres more or less, together with all and
singular the tenements, hereditaments and appurtenances

therunto belonging or in anywise appertaining, and the reven-
ion and reversions, remainder and remainders, rents, issues and
profits thereof, and also all the estate, right, title, interest, dower
