One thousand eight hundred and thirty five between
 Milly Hammett, Peter Hammett, Joel Hammett, Daniel
 Pike and Sally his wife, Babel Green, and Nancy his
 wife, Daniel Green, and Elender his wife, Jonathan Ham-
 mett and Martha Hammett, on the one part and Jesse Ham-
 mett on the other part, all of this District and State of S.C.
 and, whereas John F. Hammett late of the District aforesaid
 Decd. having died intestate seized and possessed of certain
 lands situate in said District and the above named
 persons being all the heirs and representatives of the said
 John F. Hammett Decd. and all of full age did enter into
 and agreement to sell the aforesaid lands laid out into
 common lots to the highest bidder on a credit of twelve
 months and whereas in pursuance of sd. agreement after
 duly advertising said lands for sale the lot No 1 hereinafter

 of a tract of land of sd Decd and part of an original
 grant of land granted to George Keith and bought by sd
 Decd of the heirs of Jesse Green Decd and hath such

 to a R. C. 3x thence N 25 W 26.40 to a stake thence N 60 W
