in consideration of the sum of three hundred Dollars to
us in hand paid at and before the sealing of these presents
by John H Goodwin in the State aforesaid (the receipt
whereof is hereby acknowledged) have granted bargained
sold and released and by these presents do grant
bargain sell and release unto the said John H Goodwin
his heirs and assigns all our interest (as Exors aforesaid
of V M^r Bee dead being the one half int in a certain
tract of land situate lying and being in Henderson
County North Carolina and part in Greenville Co South
Carolina containing Four hundred and fifty three
acres more or less lying on both sides of Terry's creek
of Green River on both sides of the North & So. Ca State
lines, on both sides of the old Gap creek R^d including
the head of Gap creek waters of middle Saluda
bounded as follows beginning on a Poplar on a branch
of Terry creek & runs thence S 11 W 51 chs to a Red
Oak thence S 5 W 12 chs to a white Oak thence S 75
W 20.50 chs to a mountain Bush on Terry's creek thence
down said creek to a stake near the fork thence
S 35 W 7 chs to a stake thence N 75 W 5 chs to a chestnut
on a branch thence up said Branch to a Sower wood
thence N 46 W 38.50 to a stake near Gap creek thence N 29
E 53 chs to a stake thence down the Branch to Terry Creek
thence up 2^d creek to the first branch thence up the branch
to the beginning corner being the same tract
of land that was divided to Benj Smith by Micajah
Smith & Elizabeth Smith by deed bearing date 15th
Apr 1833 & recorded in Register's office in Book 15 page
69 of Henderson Co N. C. Together with all

others lawfully claiming or to claim the same or any part
thereof
