a stake on Court Street thence S 71° 0' 14 1/2" West  
to a corner of said Street & other Street thence N 19°  
0' 13 1/2" East to a stake thence N 71° 14 1/2" West to a stake  
thence S 19° 13 1/2" West to the beginning com  
taining Forty five one hundred of an acre more  
or less Together with all and singular the rights  
members hereditaments and appurtenances to the  
said premises belonging or in anywise incident  
or appertaining To have and to hold all and  
singular the said premises before mentioned  
unto the said A. G. Davis his heirs & assigns  
forever And I do hereby bind myself my heirs  
Executors and Administrators to present and  
forever defend all and singular the said prem-  
ises unto the said A. G. Davis his heirs and  
assigns against myself and my heirs and  
any other person lawfully claiming or to claim  
the same or any part thereof Witness  
my hand and seal this 1<sup>st</sup> day of February  
in the year of Our Lord one thousand eight  
hundred and eighty one and in the one hundred  
and fifth year of the sovereignty and domain  
exercised by the United States of America
