Watson now lives & containing three fourths of an acre be the same more or less Beginning at a stone in the edge of the bottom and running S 10 1/2 E 25 2 to stone then S 36 1/2 E 3 3 2 to Pinning 3 + 0 in thereon and north 415 to a rock thence west 260 to the Beginning Rock corner. Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises being going or in anywise incident or appertaining to have and to hold all & singular the said premises before mentioned unto the said William Watson his heirs and assigns forever and I do hereby bind myself & my heirs Executors & Administrators to warrant & forever defend all and singular the said premises unto the said William Watson his heirs and
