round to the River thence down said river to
the beginning corner containing fifty Acres
more or less and bounded by lands Gilbreath
D. Burns and others Together with all and
singular the rights appurtenances and
appurtenances to the said premises belonging
or in anywise incident or appertaining to them
and to hold all and singular the premises
before mentioned unto the said Ben P. Cantrell
and his heirs and assigns forever and I do
hereby bind myself and my heirs Executors
and Administrators to warrant and fore-
ver defend all and singular the said
premises unto the said Ben P. Cantrell
and to his heirs and assigns against me and
my heirs and every other person whatsoever
lawfully claiming or to claim the same or
