of the sum of Two thousand five hundred dollars
to me in hand paid at and before the sealing of these
presents by Mary Westfield Morgan of Greenville
City in the State aforesaid, (the receipt whereof is fully
acknowledged) have granted bargained sold and
released and by these presents do grant bargain
sell and release unto the said Mary Westfield Morgan
all that house and lot in the City of Greenville on
Washington Street, containing three fourties of an acre
more or less bounded by lot of J. W. Norwood on the East
by Washington Street on the South by lot of J. M.
Westmireland on the West and by lot of C. White
on the North, and having the following corner
and distances, beginning at a stake of

W. E. Rowlands corner and running thence with said J. W.
Norwood line N. 25 $\frac{1}{4}$ E. 34.8 ft to a stake & thence N. 65 $\frac{1}{2}$ W.
78 feet to a stake & thence S. 25 $\frac{1}{4}$ W. 94.9 ft to a stake & on
Washington street. Thence with said street S. 65 $\frac{1}{2}$ E. 78 feet to
the beginning. Being the same lot of land deeded to me by
A. F. Castle on the sixth day of August 1879. See Register

all and singular the rights, members, hereditaments and
