of September in the year eighteen hundred and eighty between Wm L Rowland of the County of Bartow and State of Florida of the one part and Jas R Brown of the County of Cherokee in said State of the other part witnesseth that the said Wm L Rowland for and in consideration of the sum of Two hundred Dollars to him in hand paid by the said James R Brown at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged hath bargained granted sold and conveyed and by these presents doth grant bargain sell and convey unto the said James R Brown his heirs and assigns the following described land to wit one undivided

owned by the Grand mother of the said Rowland Mary W Lewis at the time of her death and which the said William L Rowland inherited from his mother Francis F Rowland said lands being on the waters of Grove Creek in the County of Greenville and State of South Carolina there being in said tract some three hundred or three hundred and fifty acres more or less and bounded on the East South and West by the lands of Mrs Mary Cleveland and daughter and on the North by the land of Mrs Burgess. Do have and to hold the said bargained premises unto the said James R Brown (the above described being all of the said Rowland's interest in said lands) his heirs and assigns forever in fee simple.
