eration of the sum of Twelve hundred Dollars to me paid by J M Allen of Greenville County in the State of aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said J M Allen a certain piece parcel or tract of land laying and being situate in Greenville County State of aforesaid on both sides of Mountain Creek Branch Water of Enoree River Beginning on a Post oak by the side of what is known as the Hedges Road thence N 77 W 44 to a Pine thence N 75 1/2 W 10 90 to a Post oak stump thence N 65 W 2 60 to a Dogwood thence S 45 W 27 to a Post oak thence N 80 W 10
