John W. Watson in the State of aforesaid, have granted
bargained sold and released and by these presents do
grant bargain sell and release unto the said
John W. Watson, all that piece and parcel of land
lying and being in Greenville District (now County)
& State of aforesaid on the South side of Paris moun-
tain beginning on a Pine on the original line
between Marchbanks and the Stephen Phillips place
thence running thence N 36 E 15 to P. O. thence S 63 E 35.50
to a lightwood knob thence N 47 E 17.75 to a Pine
thence a conditional line to the South corner of
Dr Hillhouse Mountain House tract thence
along Dr Hillhouse line to Cleveland's land thence
along Cleveland's line to the beginning Pine corner
containing by estimation two hundred and fifty
acres more or less adjoining the said Saw Mar-
chbanks Dr Hillhouse & Phillips lands (Reserving
to myself and my wife Malinda Watson a life
estate in the within described premises)
together with all and singular the rights members
hereditaments and appurtenances to the said
premises belonging or in anywise incident or
appertaining. To have and to hold all and sin-
gular the said premises before mentioned unto
the said John W. Watson subject to the above

claiming or to claim the said or any part
thereof
