Good partners under the firm name of Whitwire & Good in the State aforesaid, (the receipt whereof is hereby acknowledged) have granted bargained sold released and by these presents do grant bargain sell and release unto the said Whitwire & Good all that piece parcel and tract of land containing twenty five acres more or less situated lying and being in Greenville County in said State on the White Horse Road adjoining lands of Peter's Budduth Thomas Thompson and Baylis Barr being the same land conveyed to me by R.M. Sims Secretary of State on the 21st day of January A.D. 1879 Together with all and singular the rights and appurtenances and appertaining thereto

incident or appertaining, To have and to hold, all and singular the said premises before mentioned unto the said Whitwire & Good, the survivors of them their heirs and assigns forever, and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Whitwire & Good, the survivors of them their heirs and assigns against me and my heirs & every other person lawfully claiming or to claim the same or any part thereof.
