acknowledged) have granted bargained sold
and released and by these presents do grant
bargain sell and release unto the said
Caroline Brown all of those two certain
pieces parcels or lots of land situate lying
and being in the City and County of Greenville
and known as lots number 3 & 5 in the P
Johnson's survey of June 7th 1881 and better
meter and bounds as follows to wit: Lot #3
beginning on "A" street (60 ft wide) at the
