 To all to whom these
 Presents shall come, S. J. Doughtie Master in
 and for the County aforesaid. Deem Greeting:
 Whereas Thomas G. Driver and Walter Dymond Treu-
 ties on or about the 9th day of June in the year of our
 Lord eighteen hundred and seventy nine exhibited their
 Complaint in the Court of Common Pleas for this
 County aforesaid, against Alfred Dornes, demanding
 Judgment in relation to the real estate hereinafter men-
 tioned and described, and the Cause being at issue
 Came on to be heard on the 20th day of November 1879
 and such proceedings were had therein as resulted
 in a Judgment for foreclosure of the said Court
 whereby it was adjudged and decreed that the said
 Real Estate hereinafter mentioned and described be
 sold by S. J. Doughtie Master in and for this County
 aforesaid on the term and for the purpose mentioned

in the said Judgment for foreclosure as by reference thereto
 on file in said Court will appear and the said Master after
 having duly advertised the said Real Estate for sale by public auc-
 tion on the second day of January in the year of our Lord
 eighteen hundred and eighty two did then openly and publicly
 and according to the custom of auction, sell and dispose of the
 same unto D. B. Collier for the sum of eight hundred and ten
 Dollars being at that price the highest bidder thereon and
 therefore shew all men by these presents that S. J. Doughtie
 Master in and for the County of Greenville aforesaid in con-
 sideration of the sum of Eight hundred and ten Dollars to
 me paid by the said D. B. Collier the receipt whereof is hereby
 acknowledged have granted bargained sold and released and
 by these presents do grant do grant bargain sell and release
 unto the said D. B. Collier all that piece parcel or lot of land
 situate lying and being in the City of Greenville in the County
 and State aforesaid at the junction of the Atlanta and
 Charlotte Air Line Railway and the said road connect-
 ing said Railway with the Greenville and Columbia Rail-
 road being bounded on two sides by the right of way of
 said railways and on the Southern side by lands formerly
 belonging to plaintiffs as Trustees - Together with all and
 sing alor the rights members. Hereditaments and appurten-
 ances to the said premises belonging or in anywise
 incident or appertaining and all the estate right title
 claim and interest whatsoever of the parties to the Cause
 aforesaid and of such of them in and to the same and of
 all other persons rightfully claiming from vendor or by
 those or any of them. To have and to hold all and sing-
 alor the premises before presentment unto the said D. B.
 Collier his heirs and assigns forever.
