Scott, all that piece parcel and lot of land adjoining lots of Reuben Williams and Miss Mary Latimer containing one sixth of an acre of land more or less situated in the City of Greenville S.C. on cross and West Street, beginning at stake 3 x 0 on corner cross and West street running on West street 55 1/4 x 68 1/2 feet to the corner of Reuben Williams lot on West street stake 3 x 0 thence on Reuben Williams line N 27 1/4 E 101 feet to Miss Mary Latimer's lot stake 3 x 0 thence on Miss Mary Latimer's line N 5 1/2 W 7 1/2 feet to cross street stake 3 x 0 thence on cross street W 82 3/4 N 105 1/2 feet to the beginning being part of a lot bought by Jas A. David, decd of W. H. Chandler together with all and singular the rights members hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
