presents that we Joseph

William and Thomas Barton of the District
and State aforesaid have for and in consider-
ation of the sum of thirteen hundred Dollars
to us in hand paid by Solomon L Barton
of the District and State aforesaid the receipt
whereof is hereby acknowledged have granted
bargained sold and released and by these pres-
ence do grant bargain sell release confirm
and convey unto the said Solomon L Barton
all that plantation tract or parcel of land
containing by estimate three hundred and
fifty acres be the same more or less situate
lying and being in the District and State afore-
said lying on the head waters of Tyger River
it being a tract of land formerly belonging to
William Barton and conveyed by him to
James W Barton and sold by an order
of the Court and bounded as follows viz
Beginning at a Post Oak running with
the road N 4 W 12 chains to a Dogwood
thence with said road N 10 E 6.90 ch to the
fork thence W 2 1/4 W with said road to a
chestnut on the right of the road thence

W 14.90 ch to a white Oak on the old Etow line thence
with said line N 1 1/4 E 65.90 ch to a chestnut at a
large rock cliff thence S 89 1/2 E 38.00 ch to a Hickory
at the Branch thence down the meanders of the
Branch to a spanish Oak thence S 77 W 6.10 ch
to a pine thence S 16 E 8.28 ch to chestnut thence S 55
W 8.00 ch white oak down thence S 12 1/4 W 7.15 ch
to a white oak in the fork of the creek and Branch
thence South 4.92 ch to a pine on the side of the
road thence S 27 E 5.00 ch to a stake thence S 68 W
9.00 ch to a poplar at the creek thence down
the meanders of creek to where a branch
intersects it thence S 1 W 17 ch to a Poplar thence

ourselves our heirs and assigns and no further
