Know all men by these presents that Thomas

W Davis of said County and State am indebted to divers persons in considerable sums of money which I am at present unable to pay in full and am desirous to convey all my property for the benefit of my creditors without any preference or priority. Now therefore I the said Thomas W Davis in consideration of the promise and of one dollar to me paid by James A McDaniel of said County and State the receipt whereof is hereby acknowledged have granted bargained sold assigned transferred and set over and by these presents do grant bargain sell assign and set over unto the said James A McDaniel all my lands tenements hereditaments goods chattels property and rights in action of every name nature and description whatsoever the same may be

To have and to hold the same unto the said James A McDaniel in trust to sell the said real and personal property and to collect the said rights in action and then in trust to apply the proceeds of said property and rights in action in the following manner:

- 1 To pay the costs and charges of these presents including a counsel fee of Fifty Dollars to J. Q. Donaldson and the lawful expenses of executing the trust hereby created
- 2 To distribute and pay the remainder of said proceeds to the creditors of me the said Thomas W Davis for all debts and liabilities which I may be owing or indebted to any person whatsoever according to their respective priorities in law

if any there be after paying all my said debts in full the said James A McDaniel is to repay to me or my executors administrators and assigns
