E 44.00 c to a stone 3x thence S 64 E 205 chs 5 a
thence 3x thence N 74 W 1450 chs to a stone 3x
thence S 71 W 40 chains to the beginning stones
containing fifty acres more or less.

Together with all and singular the Rights
Members, Hereditaments, Appurtenances, appur-
taining or in anywise incident to the above
described land. I bind myself, my Heirs
Executors Administrators and Assigns to
warrant and forever defend all and singular
of the above described land unto J P Bayne, his
Heirs and Assigns forever, against me and
my Heirs Executors, Administrators & Assigns
and against any person or persons whomsoever
lawfully claiming the same as any part
