separate use, during my lifetime, he paying over to me the
interest accruing on the money and letting me have the
use of the other part of the same during my life time

And at my death in trust for Children as follows viz.
The Five hundred dollars to be equally divided between
my Children, the gold watch to be given to my son Lewis now
my, the diamond ring to be given to my daughter Susan Hayne
Glover and the furniture and silver ware to be equally divided
between all of my Children, signed, sealed and executed this
