Jones, in the State aforesaid, in consideration of the sum of Eight Hundred Dollars to me in hand paid at and before the sealing of these presents, by Mrs Emma J Howell of the County and the State aforesaid (the receipt whereof is hereby acknowledged) have granted, bargained, sold, aliened, released, and by these presents do grant, bargain, sell and release unto the said Mrs Emma J Howell all that lot or parcel of land lying and being in the State and County aforesaid, on the East side of the Rutherford Road, near the Corporation limits of the City of Greenville, containing in all six hundred and twenty six poles & three tenths (626 acs & 3 poles), beginning on a stone on the Rutherford Road, corner of Mrs Smiths land, thence S 89 1/4 E 8.75 ch to a stone, thence S 89 1/4 E 5.06 ch to a stone 3 x 3 on, thence N 89 1/4 E to a small cherry 3 x 3 on, thence with line of Mrs Stans land, S 41 1/2 W 8.23 ch to a stone 3 x 3 on, thence S 41 1/2 W 3.06 ch to a stone 3 x 3 on, thence with Mrs Sims line N 80 5/8 W 13.18 ch to a stone on Rutherford Road near house of Harry Glover, thence with said Rutherford Road N 26 E 6.92 ch to a stone on foot of Rutherford Road the beginning corner, joining lands of Mrs Priest and Mrs Stans, more particularly described by Plat of said land thence attached, more by W D.
