Southern all that piece parcel or tract of land situate lying and being in Greenville County in the State aforesaid on the South side of the Ridge Road on 7 Branch Water of Muck Creek South the Tiger River and runs as follows Beginning at a stone 3x on Ridge Road (W. O. Southern corner) and runs South 27 1/2 W. 10. 96 Chain to a Stone 3x (on J. P. Pitman's line) thence South 56 1/2 East 25 Chain to a Stone 3x (W. O. Southern corner) thence N 59 E 15. 25 Chain to a 9 Black Gum 3x (W. O.
