 1885. Commencing January the first, Next ensuing, that  
 I Elizabeth Hanley of Summerville County and State  
 of South Carolina, do hereby lease demise and let unto  
 Paul J. Hurdell a certain piece of parcel of land sit-  
 uate in the Township of Summerville County and State  
 aforesaid, with all the buildings thereon standing  
 and appurtenances to the same belonging, lands  
 and divided as follows, with a small dwelling  
 house and some 100 Acres, some twelve acres of plow  
 land and some twelve acres in natural forest ad-
