Mr. Mary E. Bowell deceased, Dr. P. W. Jones and others.
Also that a tract or parcel of land situate
lying and being in said County and state on
both sides of the said Augusta Road about five
and One Half Miles below the said City of Gre-
nville, lately purchased by me of Jas. M. Ash-
ton, and said to contain five and one half
acres more or less, bounded by Estate lands of
