Cooksey of said County, in the State of said (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said A. Cooksey, all that certain piece, parcel and tract of land situate lying and being in said County and State, about four miles from Greenville, S.C. on the North side of the road leading from Greenville City to Batesville Factory, adjoining lands now or formerly belonging to Geo. Pool, Geo. Walker and others, containing forty-three and one fourth ($43\frac{1}{4}$) Acres, more or less, and having the following lines, metes and bounds, to-wit: Beginning at a stake 3x, and running thence $72\frac{3}{4}$ W. 21.50 to a stone 3x 3x; thence $86\frac{1}{4}$ W. 21.25 to a stone 3x 0.1m; thence $82\frac{1}{4}$ E. 19.00 to a stake 3x, on the said Road (corner of Pool fence), thence down said road to the beginning corner, bounded by lands now belonging to R. King, H. S. Stroud and others being same tract conveyed by J. L. Harbin, Exor. and then the Harbin to P. H. Verdier and Hamby, & by them to Thomas G. Glenn.
