Hodge, and supposed to contain about nine-tenths of an Acre. Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. To have and to hold, all and singular the said Premises before mentioned unto the said Mary Cox her Heirs and Assigns forever. And I do hereby bind myself my Heirs, Executors, and Administrators, to warrant and forever defend all and singular the said Premises unto the said Mary Cox her Heirs and Assigns, against one and any Heirs lawfully claiming, or to claim the same, or any part thereof.
