 parcel and lot of land, situate, lying and being
 in the City of Greenville and County and State
 of aforesaid, on or near the Rutherford Street bounded
 by lots of McDaniel, Johnson and others. Being the
 lot conveyed to Mrs. M. E. Easterling by H. E. Knight
 by deed bearing date the twentieth day of September
 in the year of our Lord one thousand eight hun-
 dred and eighty three and recorded in Book

 paid at and before the sealing of these presents, by
 Minnie V. Durham, paying one thousand dollars
 and Emily S. Burke paying sixteen hundred
 and sixty six ^{60/100} Dollars, the receipt whereof is
 hereby acknowledged; have granted, bargain
 sold and released, and, by these Presents do grant,
 bargain, sell and release unto the said Minnie
 V. Durham an undivided one twelfth interest
 and unto the said Emily S. Burke an undivided
 one third interest of, in, or to one lot of land with
 the buildings and improvements, situate in the
 State and County of aforesaid, in the corner of Main
 and North Streets in the City of Greenville, with
 the following dimensions and admeasurements,
 Beginning on the corner of Main and North Streets
 and running thence N. 20 E. one hundred and twenty
 and one third feet with Main Street, thence S. 70 E.
