A. and Alma Tinsley and our heirs, and all and every other person or persons lawfully claiming or to claim, any Estate, Right, Title, Trust, or Interest, of, in, or to, the said Land above described and all and singular the Premises hereinbefore mentioned, and intended to be hereby granted and released, or any part or parcel thereof, shall and will, from and at all times hereafter, at the reasonable request and proper Costs and Charges of the Land, of the said Sarah E. Poole or her heirs, and assigns, lawfully and lawfully, and execute
