 To: Deed Know all Men by these Presents,
 Frances Bellanus that I, V. A. Bellanus of Greenville
 County in the State of aforesaid, in consideration
 of the sum of the love and affection I have for my
 wife Frances Bellanus, as well as five Dollars to
 me in hand paid at and before the sealing of
 these presents, by my said wife Frances Bellanus
 (the receipt whereof is hereby acknowledged) have
 granted, bargained, sold and released and by these
 presents do grant, bargain sell and release unto
 the said Frances Bellanus all that tract or parcel
 of land whereon I now live, situated in Greenville
 County and State of aforesaid on the North East side

of a branch of Emorys River, Beginning at a stake 3x by a Red Oak at the fork of Road, and running thence S. 47 1/2 E. 79 1/2 to a stooping Poplar at the head of a branch, thence down said branch with the various meanders to a stone 3x on the line of the John Tubby grant, thence with said line S. 23 1/2 W. 5 1/2 to a Spanish Oak 3x cut down, thence N. 77 1/2 E. 27 1/2 to a stone 3x, thence N. 13 1/2 W. 36 1/2 to a Hollow Post Oak stump, thence N. 23 1/4 W. 11 1/2 to a Large White Oak 3x 3x, thence S. 65 W. 17 1/2 to a Red Oak 3x 3x dead, thence N. 24 W. 25 1/2 to a stone 3x and old Painter on the old Tugels Road, thence along and with said road to the beginning, Containing one hundred and forty five (145) Acres, More or less, Except 12 1/2 Acres included in the above boundary now in litigation and claimed by Hula Burns and Baylis Burns, which I do not convey, Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.
