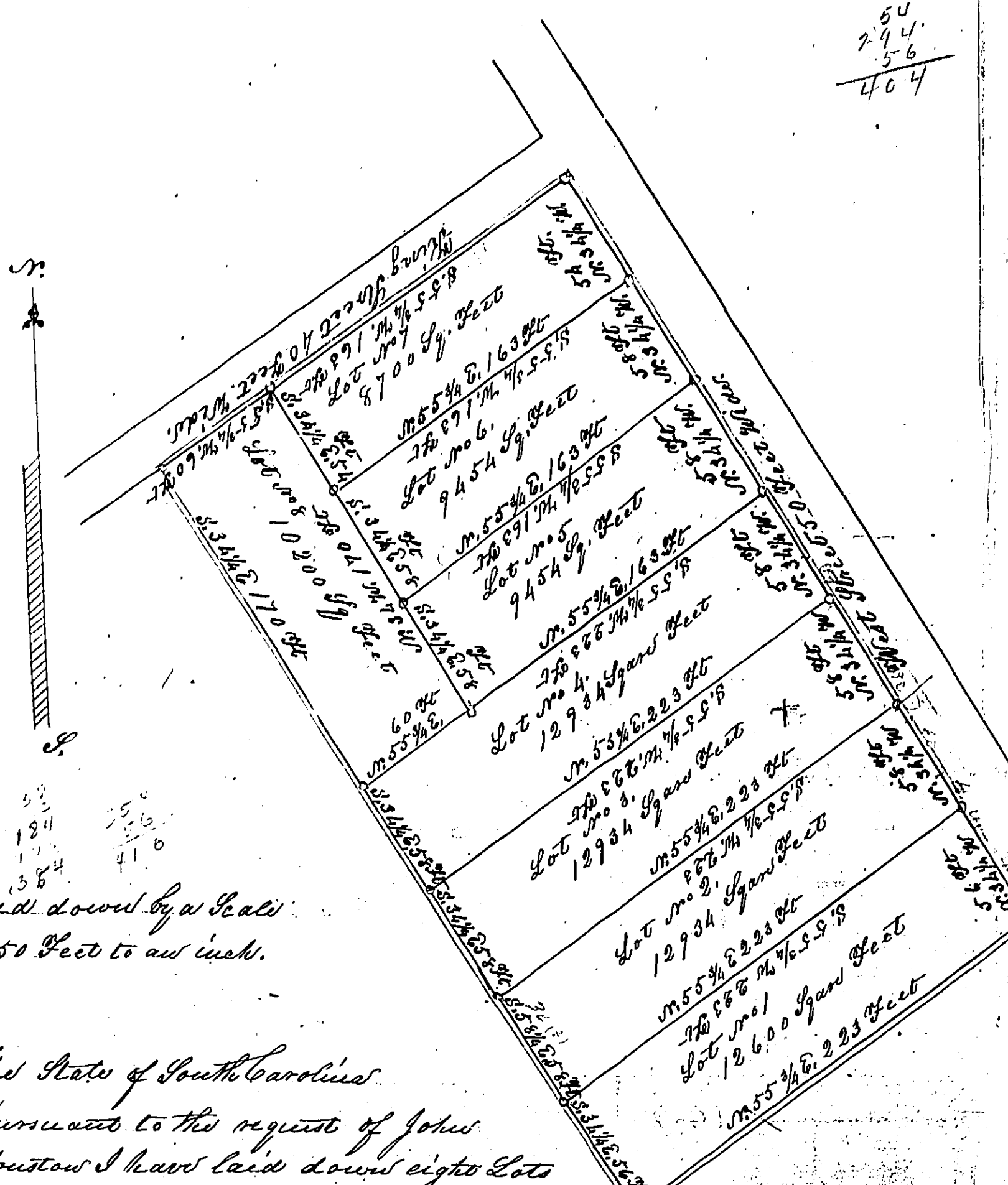

(the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO  
GRANT, bargain, sell and release unto the said Thomas J. Glenn all that free par-

cel & lot of land situate lying & being in the City of in the County of  
State aforesaid containing one (1) Acre more or less & bounded by lands  
of Cyrus Randall Thomas J. Glenn & others being the same Lot con-  
veyed to me by Sallie M. Good May 12, 1881, said conveyance  
being recorded in R.M. Office in Book M.M. page 88 on -  
August 6, 1881

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Pre-  
mises belonging or in anywise incident or appertaining.  
TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said  
Thomas J. Glenn his Heirs and Assigns forever.  
AND I do hereby bind my Heirs, Executors and Administrators, to  
warrant and forever defend, all and singular the said Premises unto the said Thomas J. Glenn  
his Heirs and Assigns, against me and my Heirs, and against  
every person whomsoever lawfully claiming or to claim the same or any part thereof.
