Know all men by these presents that J L Westmoreland of the State of South Carolina for the purpose of establishing a school do hereby for that purpose release unto Joseph McMillen & William H Goodlett a certain parcel of land containing two acres on the water of South Tyger near to wisely burrows & on a branch of the long Branch to comprise a certain spring of water on the N.W. side of the Rutherford road all of which premises is here by conveyed & released unto the said Joseph McMillen & William H Goodlett & their successors for the purpose above named so long as it shall be necessary & is used for school purposes & in future I shall not have during the continuance of a school or in the intervals between schools any more right or privilege to said land house or spring than other person interested in said school but in every respect shall be on equality with other persons claiming an interest in said school I do further agree that if the employers of said school shall desire it that I will at any future time when they shall have the land surveyed to alter this title so as to specify the particular boundary of said land & this release is obligatory on my successors or heirs in witness whereof I do hereunto set my hand in the presence of
