Walker's lot and running thence North Eighty
Five Degrees West N 85 W One hundred (100)
feet to a stone & William Means corner thence
North seventy nine Degrees West N 79 W One
Hundred and Fifty (157) feet to a corner in
a Branch thence South Two and one half
Degrees West S 2 1/2 W Fifty (50) feet to a
stone & thence South sixty seven Degrees East
(S 67 E) and with the meander of the Branch
One hundred and thirty one (131) feet to a
