 released and do hereby grant bargain sell and
 release unto the said B T Whitnize the following
 pieces parcels and lots of land situate in the City
 and County of Greenville in the State aforesaid
 to wit a piece of land four feet wide along the
 Eastern side of the lot of land conveyed to him
 by me by deed dated the twenty third day of

February 1891 and recorded in the R.M.C. office in Book
 W.W. Page 487. said strip of land four feet wide running
 back from Laurens Street along the northern side of his
 lot to its intersection with the Eastern line thus giving
 him a front on Coffee Street of fifty two feet instead of
 forty eight as heretofore and on Laurens Street a front
 of twelve feet instead of eight feet as heretofore.

Together with all and singular the rights members
 hereditaments and appurtenances to the said premises
 belonging or in any wise incident or appertaining.
 To have and to hold all and singular the said premises
 unto the said B T Whitnize his heirs and assigns forever.
 And I do hereby bind myself and my successors to
 warrant and forever defend all and singular the said
 premises unto the said B T Whitnize his heirs and
 assigns against myself and my successors and all
 other persons lawfully claiming or to claim the same
