Campbell, all that certain

piece, parcel and tract of land, situate, lying and being in the County and State aforesaid, adjoining lands of Mr. Scott, Charles Danforth, Thomas W. Austin, and my own, containing two hundred and forty three and 37/100 acres more or less, and having the following lines, meters and bounds to wit: beginning at a pine, on the road to Seale's Mill, and running thence S 41 1/2 W 20.25 to a stone 3x; thence S 07 E, 1.02 to a stake, 3x; thence S 30 1/2 W, 200.00 to a stake; thence S 05 W, 6.50 to a stake; thence N 89 1/2 W, 2.25 to a stone 3x; thence N 65 W, 16.00 to a Post Oak 3x; thence N 85 1/4 W, 207 to a stone 3x; thence N 12 1/2 E, 21.00 to an oak; thence S 86 E, 15.20 to a stone 3x; thence S 1 E, 12.00 to a stone 3x; thence S 27 1/2 E, 9.25 to a stone 3x; thence S 82 E, 6.00 to station on Road to Seale's Mill; thence S 79 E, 9.50 to a station on said road; thence S 07 1/2 E, 11.50 to a stone 3x; thence S 57 E 9.45 to the beginning corner,
