of record all of that piece parcel and tract of land lying and being in Fairview Township in the County and State aforesaid on the west side of Ready River, and on Cripple Creek, southerly of the same, having the following lines and bounds, commencing at the ford of Cripple Creek running N 37 1/2 W 130 to a corner, thence N 22 1/2 W 150 to binding road, then N 4 1/2 E 17.00 to another binding road, then N 14 1/2 E 4.00 to another bend, then N 7 1/2 S 55.00 to another bend, then N 8 1/2 S 40 links to corner in center of road opposite stone in 6.00 W 4.50 to corner in center of river opposite stone on bank, then down the meanderings of the river to S 1/2 E 30 E, then N 30 E 3.00 to stone 3 x 0, then S 60 E 6.00 to stone 3 x 3 on, then down the meanderings of the river to the mouth of Cripple Creek, then up the meanderings of Cripple Creek to the ford, which is the starting point containing one hundred and twenty two acres, bounded on the East by lands of S E Harrison, on the North by lands of Mrs Rattie G Harrison, on the West by Ready River and on the South by Cripple Creek.
