Smith all that tract or parcel of land, situate, lying and being in Greenville District and State aforesaid on both sides of Ballenger's Creek of Enoree River, being part of the real estate of Daniel Wood, (dec'd) Beginning at a Post oak 3x6x on the Greenville and Spartanburg line, and running thence with said line $N\frac{1}{2}^{\circ} E$ 20.95 to a small Hickory 3x Post oak gone. Thence West 3.00 thence north 2.87 to a Stone. Thence West 5.00 to a Stone 3x. Thence $N\frac{1}{2}^{\circ} W$ 18.90 to a Stone 3x. Thence $S\frac{1}{2}^{\circ} W$ 6.11 to a Red oak old blaze.
