GRANT, bargain, sell, and release unto the said

*W. F. Shackleton* all the undivided  
*one half interest of the said B. G. Perry, in all that piece*  
*parcel or tract of land situate lying and being in the County*  
*and State aforesaid, containing one hundred and sixty*  
*acres more or less known as the Rock House tract adjoining*  
*lands of W. F. Shackleton, W. C. Cleveland, William Wilkins*  
*and others*

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises  
belonging, or in anywise incident or appertaining; and all the estate, right, title, claim, and interest whatsoever, of the  
parties to the cause aforesaid, and of each of them, in and to the same; and of all other persons rightfully claiming from,  
under, or by these or any of them.

*W. F. Shackleton* his heirs and assigns forever.
