the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO GRANT, bargain, sell, and release unto the said

Samuel McDaniel, all that tract or parcel of land situate in the County and State aforesaid in the City of Greenville near the Allen School House, containing one-half acre, more or less, being part of the land bought by *Wm E. Earle* at a sale of the real estate of *D. Randall Croft* deceased, made by the Sheriff of Greenville County commencing on the S.W. corner of an alley running midway the square, thence N 74 1/2° E 2.67; thence N.W. 2 1/4 (1.80) thence S 73 W 4 1/2 and thence S 15-8 1/4 to the beginning corner.
