release unto the said Edwin Pepper, all that piece, parcel or tract of land lying,  
being and situate in Greenville County, Greenville Township, and on the branch waters of  
Sandy Creek and containing one hundred and eighty acres, more or less, and has the  
following more, bearings and distances, to wit: Beginning on a stone in road 3x7m. thence  
S. 52 1/4 E. 5.25 to a stone 3x7m., thence S. 81 E. 8.00 to a stone in branch 3x7m., thence up said  
branch with its meanderings to a black gum 3x7m., thence S. 1/4 E. 9.25 to a stone  
3x7m., thence S. 34 N. 6.10 to a Poplar 3x7m., thence N. 86 N. 10.50 to a stone 3x7m.,
