 release unto the said William T. Stand all that parcel or lot of land with build-
 ings thereon situate, lying and being in the City and County of Greenville
 at the north east corner of Falls St. and Hudson Alley as follows, having the
 following metes and bounds: Beginning at a point at corner of said lots
 and, running thence with Fall St. N. 69° E. 16' to a stake thence S. 69°
 E. 36' to a stake thence S. 70° W. 16' to a stake now Hudson Alley, thence
 with said alley N. 69° W. 36' to the beginning, plus all that other piece
 parcel or lot of land lying, next Hudson Alley with buildings thereon begin-
 ning at a point on Hudson Alley and running thence N. 70° E. 14' to a stake
 thence N. 70° E. 100' to a stake, thence S. 70° E. 14' to a stake thence S. 71° E. 39' to a
