(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. J. Earle

all that piece parcel and tract of land situated lying and being in County of Greenville and State aforesaid on Mcbee Mill road beginning at a stake on said road on corner of S. J. Earle's land and running thence along said S. J. Earle's line S 56° E 7.75 chains to a rock pile; thence S 17 1/2° W 6.00 chains along G. Mcbee's land line to a rock on Mcbee Mill road; thence westward and northward along the said road to the beginning corner, containing four and one half acres more or less.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said J. J. Earle her Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said J. J. Earle and her

Heirs and Assigns, against myself and my Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
