Thence along said road E. 1/2 Sec. 101 a corner in a road, thence along same N 61/4 Sec. 2 1/2 to a stone at Black Gum tree at head of branch. Thence down said branch into the meander to a corner below a log. Thence N 82 1/2 Sec. 7 1/2 to the beginning corner, containing two acres more or less
