Sarah Ann Lewis all our right title and interest in and to tract No 6 of the Lewis deceased estate lying and excepted to much thereof as has been conveyed to me and further as my share in tract No 6. The following is a description of the said estate to be conveyed situated lying and being in the County of Greenville State of South Carolina on the waters of Lewis Creek tributary to the full of the River. Bounded as follows tract No 1 of 200 acres (and draw) of Providence land N. 81 1/4 E. 26.25 to the north road S. 81 1/4 W. 4.00 to the stake S. 56. 3.50 to the stake N. 81 1/4 W. 5.00 to the stake (near large pine) N. 81 1/4 W. 10.60 to the stake (in Providence line) N. 1. W. 5.41 to the beginning corner containing thence across same as before

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said Sarah Ann Lewis her Heirs and Assigns forever.

And we do hereby bind ourseives, our Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said Sarah Ann Lewis her Heirs and Assigns forever

Heirs and Assigns, against us and our Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof. WITNESS our Hand and Seal this 17th day of May A.
