Stator* (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *John J. Stator* all that tract or parcel of land

*lying and being in Greenville County, land of the estate of Samuel Campbell deceased and being a part of the tract of land purchased and conveyed to him by him to me on the 13th day of March 1899. And said land is described in Register of Deeds Greenville County on the 23rd March 1899 and in Book 2 to page 104 said books at page 3 on a plat made by me in District O. C. in March 8th 1899. and contains (more or less) a certain tract or parcel of land containing more or less and bearings and distances to wit: Beginning on a line 34.00m on Piedmont Road thence N. 27.1/2 W. 19.75 to a stone originally a Chatham 34.0 m thence N. 24.1/2 E. 37.50 to a yellow stake on a parcel 37.0 m thence S. 1/2 W. 1/2 to a post 34.0 m to a corner corner thence S. 1/2 W. 1/2 to the beginning corner and adjoining lands of *John J. Stator* and *John J. Stator**

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said *John J. Stator* Heirs and Assigns forever.

And *I* do hereby bind *myself* Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said *John J. Stator* Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
