All that certain tract or parcel of land situate lying and being in the County of Greenville and State aforesaid, in the fork of the Saluda Gap and Jordan Road beginning on a stone at the head of a Gully on the Saluda Gap Road and running down said road to the old line between us and W Moon, thence with said line to the Jordan Road, thence up said road to the mouth of the gully, opposite the beginning corner, thence up said gully to the beginning corner, containing by estimation Two & 1/2 Acres more or less,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Jacob Belcher His Heirs and Assigns forever.
